Subject - Visitors - PacifiCorp (Pacific Power)- Alisa Dunlap - EPA Green Power / Blue Sky

Synopsis: In September, Council was presented with correspondence indicating the City's removal from an EPA Green Power partnership with PacifiCorp after our green power use fell under the required percentage of 50% in the program requirements. The EPA requires the local government partner to be in good standing in order for the larger Community to qualify, even if the overall Community is already hitting their benchmark. (The Community requirement is 5% and the Gearhart Community is meeting at 13%.) Nothing has drastically changed in City facility power use, but the benchmark changed from 25% to 50% and now City (local government) facilities are below measuring at 39%.

Additionally, the City participates in PacifiCorp's BlueSky Renewable Energy Program, which: Guarantees renewable energy was produced and delivered to the grid, which helps reduce the need for non-renewable resources production in the region where the renewable energy facility is located.

Pacific Power purchases renewable energy certificates equal to the partner level the City wishes to purchase as an additional charge to the power bill each month. A renewal quote for this year is attached, and Council should discuss which direction they'd like staff to take.

Alisa Dunlap, our local Regional Business Manager with Pacific Power, is here to answer any questions and elaborate on both of these two programs.

Blue Sky Quantity Savings Program discount: Pacific Power offers a discount on a sliding scale with minimum purchase of 101 blocks per month over a period of one year (1,212 blocks minimum purchase). The cost per 100 kilowatt-hour block ranges from \$0.71 to \$1.94, depending on the quantity of blocks purchased.

When you enroll in Blue Sky, Pacific Power purchases renewable energy certificates equal to your Blue Sky purchase; this guarantees that renewable energy was produced and delivered to the grid which helps reduce the need for non-renewable resources production in the region where the renewable energy facility is located. For every unit of renewable electricity generated, an equivalent amount of renewable energy certificates are produced. Your purchase also helps build a market for renewable energy and may have other local and global environmental benefits. The renewable energy supported by Blue Sky customers is above and beyond that which Pacific Power generates or acquires to serve all its customers and meet state mandated renewable portfolio standards. RECs purchased on behalf of Blue Sky customers are tracked and retired in an independent renewable energy tracking system ensuring that each REC is counted only once. PacifiCorp serves as the purchasing entity and the RECs are tracked in PacifiCorp's WREGIS Blue Sky account for the overall program rather than in the name of individual customers. The RECs are exclusively owned- and retired- on behalf of all Blue Sky participating customers. The company does not use the RECs for any other purpose.

Your participation in the Blue Sky program helps to reduce the carbon footprint associated with your electricity use.

Dear Chad:

????We recently emailed you about the status of your participation in the EPA's Green Power Partnership.

The email explained that based on our review of the City of Gearhart, OR's electricity and green power use, reported on your behalf by Pacific Power, your organization's green power use is under the required percentage of 50% in the program requirements. We regret to have to inform you that, at this time, we are suspending you from the Partnership. This means that the City of Gearhart, OR will be removed from all official listings of Partners. In addition, we will remove your Partner page from the Partnership website.

In addition, because the City of Gearhart, OR is no longer a Green Power Partner, please remove any references to your organization's former status as a Green Power Partner, as well as any use of the Green Power Partner Mark, from your website and any other promotional materials. As stated in EPA's Mark Use Guidelines (PDF), only Green Power Partners may use the mark.

Please also remove any references to your organization's former status as a Green Power Community. EPA's Green Power Community Road Signs Guidelines (PDF) specify that Communities that terminate their Partnership must remove all GPC road signs.
