After reviewing the years of work that the City of Cannon Beach went through, they began with a "Vetting" committee that basically was the OR for the City. In speaking with Mike Morgan who was the Chair, he questioned whether the OR would be too Construction "heavy" and not as broad brush as the Council wanted. This would be defined in the Scope of work for the hire.

An Owner's Representative is not the same as a Project Manager. This needs to be clarified and highlighted so as to avoid any conflict of interest with the Project manager in a Design/Build firm, an Architectural firm, or a Construction Company. The OR would act independently.

Owner's Reps do not "build" anything. They represent the Owners/City and monitor the progress of the Architect's Project Manager, or a Design/Build teams Project Manager.

When considering the OR and tasks to be included in the scope of work, I'd like to see what they could repurpose from the last round of proposals.

A clear graphic would be taking the design drawings and showing the citizens how 3' of water would impact a building on the existing site, vs one that would be 3' higher in elevation. Implications from this comparison would be an important discussion for the citizenry.
