BE IT RESOLVED that the City Council, the governing body of the City of Gearhart, hereby adopts the budget for the City of Gearhart for the fiscal year 2025-2026 in the total of \$7,948,836. This budget is now on file at 698 Pacific Way, Clatsop County, Gearhart, Oregon and on the City website.

IMPOSING THE TAX

BE IT RESOLVED that the following ad valorem property taxes are hereby imposed for tax year 2025-2026 upon the assessed value of all taxable property within the City of Gearhart:

- (1) In the rate of \$1.0053 per \$1,000 of assessed value for permanent tax rate;
- (2) In the amount of \$305,116 for debt service for general obligation bonds;

CATEGORIZING THE TAX

BE IT RESOLVED that the taxes imposed are hereby categorized for purposes of Article XI, Section 11b as:

General Government Limitation


Permanent Rate Tax.....\$1.0053 per \$1,000

Excluded from Limitation

General Obligation Bond Debt Service.....\$305,116
