**INSPECTION OF PROPERTY:** The property offered may be inspected by contacting Gearhart City Hall at (503)738-5501, between the hours of 9:00 am to 3:00 pm local time to arrange an appointment.

**BID SUBMITTAL:** Bids must be signed by an authorized signatory of the bidder on this Bid Agreement Form and be delivered by mail or in person in a sealed envelope not later than 4:00 pm local time on Monday, February 24, 2025 to Gearhart City Hall, at 698 Pacific Way, PO Box 2510, Gearhart, OR 97138; and, labeled: "2025 Bid Form". Bids e-mailed or otherwise electronically submitted cannot be accepted and will be rejected.

**BID OPENING:** Bids will be opened and read aloud at 10:00 am local time at the Gearhart City Hall, at 698 Pacific Way, Gearhart, OR 97138 on Tuesday, February 25. Bidders are not required to be present at the bid opening. Successful bidders will be notified by telephone and/or email, if provided.

**PAYMENT AND REMOVAL OF PROPERTY:** Payment by cashier's check payable to the City of Gearhart. Full payment must be received within three (3) business days, and the property removed from the City of Gearhart property at the buyer's expense not later than 4:00 pm local time, Friday, February 28. The City of Gearhart may reclaim ownership of any item not removed by that time. Security and other building or access restrictions may apply to the removal of the property and must be coordinated by the bidder with Chad Sweet, City Administrator, at (503)738-5501 during normal business hours. The buyer is responsible for providing proper safety devices and equipment, licenses, and permits to meet all government safety standards and legal operating requirements, and for insuring awarded items against risk of loss while they remain on the City of Gearhart premises and throughout the removal process. The Buyer agrees to provide adequate liability insurance while on the City of Gearhart property for the purpose of removal of goods, and will indemnify and hold harmless the City of Gearhart.
