

Business License Term and Fee - I understand that the license term shall be the 12-month period beginning on January 1 of each year and ending December 31. If any business comes into existence or for the first time commences its operations within the City at any time after January 1 of any business license period, the license fee payable for the current business license period shall be prorated as of the beginning date of the quarterly period during which the activity begins. The quarterly periods, for the purpose hereof, shall be on the first days of January Q1, April Q2, July Q3, and October Q4 of each year. Businesses that operated in the City in previous calendar years are not eligible for proration.
