As owners of the property located at 715 H Street (AKA The Lodge) we are keenly interested in the City's May 7, 2021 report entitled "A2 zone Summary (Possible Amendment Considerations)." Please address the following questions and considerations as you proceed with deliberations on this matter.

Although the report is framed as a consideration of tree or vegetation removal, the last paragraph suggests a 200-foot setback for "structures." Please explain why structures are included and specify the kind of structures. The Clatsop County maps I've consulted suggest that a good portion of our land would fall within this setback. If this proposal advances, please provide measurements of the amount of the above-the-bank property that would be included.

Please provide a more specific description of the environmental problems the proposed measures aim to address and how these measures would address them. The report mentions goals of preserving habitat for fish and crab and shoreline stabilization. As pertains to habitat, however, it states that, per the ODFW, vegetation does not add significant habitat in such saltwater estuaries. As pertains to shoreline stabilization, the report states that the City finds it debatable whether trees or vegetation are better stabilizers. Our property – and much of that along the estuary – is very different from the dunes. The mostly flat, unfertilized lawn does a fine job of stabilizing the soil above the bank, whereas the trees add little in terms of mitigating above-the-bank erosion.

Please understand that we have no quarrel with the value of trees. I have planted more than 100 shore pine on our property, have purchased tree-based carbon offsets and have volunteered for Friends of Trees. I'm just speculating here, but this report APPEARS to be proposing a tree policy in the guise of an estuary policy, one whose measures promise little if any beneficial impact on our section of the estuary. If the concerns that generated this report are really about trees — and the benefits they bring when thoughtfully placed — why not focus discussion on measures that would incentivize the planting and protection of trees? Otherwise, I fear that undue, unnecessary and unintended harm will fall on those whose property falls within the proposed setback.

Finally, we do find the specific issue of bank stabilization to be a perennial concern. We have generally been able to mitigate bank erosion with rip-rap, sometimes supplemented with plantings of beach grass. Apart from Elk climbing up from the beach, the main problem I see right now is the recent abundance of large tree trunks and stumps that crash against and provoke erosion of the bank. We would be interested in discussing the possibility of a collective response to this issue.


City conversations have commenced about how to protect the riparian ecosystem along the edge of the Necanicum Estuary at Little Beach.

One idea is to regulate tree and vegetation removal by establishing a 200-foot setback measured inland from the northerly edge of the A2 zone. This concept is a blatant overreach. It would not just apply regulatory boundaries over estuarine and adjacent bluff areas, but would restrictively envelope the entirety of almost all ten frontal properties, including structures, landscaping and such, and in doing so would have the potential to negatively impacting property usages and valuations.

As a full time Little Beach resident for nearly 15 years, I know that the estuary is a dynamic creature and that the shoreline is a complex and evolving bionome. Who can deny that the well-being of the estuarine edge is part and parcel of the health of the whole Necanicum Estuary? Probably no one. Who would deny that government should have a role in keeping the estuary alive and well? Frankly, probably more than a few people. As for me, I can see the point of the City wanting to prevent riparian damage with new regulations. On the other hand, I am against such overkill as this floated A2 Amendment notion.

Go back to the drawing board, please. Define the problem, it's scope, the impact of any solution on the estuary and the private property owners, and even the merits of doing far less or, ideally in my opinion, tabling the matter for good right now.
